## Review of 6/28 report to the Board

**Directive:** Return to the Board on or before June 28, 2022, with a plan to address previous direction provided on June 8, 2021, to use our existing solid waste resources to come up with a systemic response to syringe collection, by either expanding contracts with current providers and/or releasing an RFP or RFQ to solicit such services, including a potential on-demand response component.



Unfortunately this report was not responsive to previous Board direction. In the meantime he and I will meet with the HSA director to go over specific concerns.</li> <li>When the item returns in August, we would like HSA to identify 8 additional disposal kiosks to be installed and managed by the County.</li> <li>And also that the August report should contain, per previous Board direction, the number of needles collected in the kiosks by the Downtown Streets Team, Save our Shores, the City of Santa Cruz Parks and Recreation. All of them keep this data and we've asked that they be in these reports going forward, and we'd like to see it in the report when it comes back in August."</li> </ul>	Pending

From June 2020 onward, there has been a steady decline in syringe collection and distribution through County SSP exchange
