County of Santa Cruz will have an election to cover a total of \$30 million over the next 30 years. Monterey County will also have an election to cover \$30 million. Funding will be used to increase the flow of water by widening certain parts of the river and rebuilding the levees around the Pajaro area. Whole project will cost \$394 million.
